- Operate appropriate hazmat equipment.
- Follow instruction to carry out decontamination procedures.
- Decontaminate, Service and clean hazmat equipment.
- Hazmat respond system.
- Practical on Hazmat PPE and mitigation techniques.
- Observed reporting protocols accordance to organization.
- Conduct safety check on breathing apparatus.
- Assist in the search and rescue.
- Communicate details of casualties.
- Assist in the closure of search and rescue operations.
- Practical on hazmat mitigation techniques.
